UPDATE – 8/10/2020:

When we sent this out, we had inquired about any regulations concerning use through DOT and were told that they were allowed on a school bus interior but that NYSDMV regulated any exterior signage.

We just received the following from DOT:

NYSDOT has consulted with NYS DMV for their opinion on displaying “face masks required” signs on the exterior of school buses and they are not aware of any statute, regulation or executive order that would allow the use of this sign. It would be a violation of §375(21-h) of NYS VTL to post such sign on subject motor vehicles (except such motor vehicles operating in a city with a population of one million or more).

These signs will be allowed to be displayed **ONLY** on the INTERIOR driver’s bulkhead area of school buses. The signs may not obstruct or cover any required FMVSS decals.

NYS VTL(21-h) states:

It shall be unlawful for any motor vehicle having a seating capacity of more than seven passengers and used primarily to transport pupils or pupils and teachers to and from school to be mounted with, or have placed or installed thereon any sign, placard or other display except as provided by law. Provided, however, that the provisions of this subdivision shall not apply to such motor vehicles operating in a city with a population of one million or more.

In Short: These are allowed on School Bus interior but NOT to be used on the School Bus exterior.
